# Arbitration Claus(e) is Coming to Town

#### **About this Webinar**

As the festive season approaches, SIArb's CPD programme for 2021 ends by focusing on the starting point for any arbitration: the arbitration clause. This seminar will examine lessons to be learned from recent case law and practice for the drafting and interpretation of arbitration clauses, including a discussion of the problems currently crossing the desks of arbitral institutions and parties' legal advisers. Our well-known panel will draw on their experience as counsel, as arbitrator and in roles at arbitral institutions to discuss, amongst other issues:

- misnaming arbitral institutions and other common ambiguities and errors;
- how to assess whether arbitration clauses are "compatible" a common requirement under institutional rules for the consolidation of arbitrations arising from different agreements;
- disputes as to the scope of an arbitration clause, including overlapping and conflicting dispute resolution clauses, noncontractual claims, and statutory rights; and
- objections based on failure to comply with pre-arbitral steps in multi-tiered clauses: what issues are being raised and how do different institutions deal with them?
