Symposium Format

This Inaugural Symposium provides a distinctive and interactive forum for participants to discuss current issues and developments in the field of commercial arbitration.

There are no set speakers or speeches. Participants will be invited to submit topics for discussion in advance of the Symposium. The topics will be grouped into themes and allocated to one of the 3 working sessions, at which participants will be invited to introduce their topic. The topic is then presented for discussion, under the expert chairmanship of the Co-Chairs, all of whom are experienced practitioners in the field.

The objective is to generate a free-flowing discussion of current issues in commercial arbitration practice guided by the Co-Chairs.

There are limited places available for this Symposium so as to maintain the efficiency of the format, and preserve the quality of the discussion. Participants are not required to have any particular level of practical experience in arbitration.

About the Symposium Co-Chairs

Professor Lawrence Boo | Resident The Arbitration Chambers, Singapore

Lawrence Boo has recently completed his term as SIAC's Deputy Chairman. He is one of the most active arbitrators in Singapore. He has sat as arbitrator in more than 165 cases and written numerous awards. His cases included those administered by the ICC, CIETAC, SIAC, LCIA, HKIAC and KLRCA. He is the author of *Halsbury's Laws of Singapore Volume 2 - Arbitration* (Lexis-Nexis 1998 and 2003 Re-issue) and the chapter on Singapore in the book *International Handbook on Commercial Arbitration* (Kluwer 1996 and 2002 Supplement) and numerous articles. He currently heads The Arbitration Chambers and teaches at the NUS Law Faculty, Bond University (Australia) and Wuhan University (China).

Mr. Philip Jeyaretnam SC | Partner Rodyk & Davidson LLP

Philip Jeyaretnam is a Senior Counsel specialising in commercial litigation and international arbitration with a focus on construction law. He has also been appointed as arbitrator in SIAC and ICC arbitrations, as well as holding several ad hoc appointments. He is a former President of the Law Society of Singapore, and was the first Chairman of the Society of Construction Law, Singapore.
